MINUTES FROM THE NOVEMBER EXECUTIVE COMMITTEE MEETING

President Jack McCoy called to order the November 21, 2024, Executive Committee meeting of the SAM Assembly 138 and the Alliance of Illusionists at 6:00 pm in the Illusion Warehouse museum room. A quorum of five officers were present. Absent were Treasurer Bernie Trowbridge and Historian Cindy Bighorse. Also in attendance were members in good standing Gary Poe and Joey Byers.

Treasurer Bernie Trowbridge sent the club's Treasurer's report. At the time of the last report, the clubs had a balance of \$1029.21. Since then, the clubs have brought in \$227.07 from 2025 dues, cash received from guests attending the Losander lecture, and a transfer of all funds from the Club's PayPal account. The club had one expense, the monthly \$13.86 MailChimp charge. This leaves the club with an ending Operating Account balance of \$1242.42.

Minutes of the October Executive Committee Meeting were approved as printed in the November edition of the SERVANTE newsletter.

Tentative 2025 officer candidates include Gary Poe for President, Joey Byers for Vice President, Bruce Chadwick for Secretary, Lonnie Olander for Treasurer, Jack McCoy for Sergeant at Arms, Hare Evison as Historian, and William Weebo for Member at Large. Secretary Chadwick reminded the committee that at the November and December Monthly Clubs Meeting, the clubs must hold a Special Executive Committee Meeting to take any other officer nominations from the floor. The election of officers proper will be at the December Monthly Club Meeting.

Since the last Executive Committee Meeting, Secretary Chadwick sent the Executive Committee multiple emails regarding the required five year update and review of the Club's Bylaws. Bruce went over recommended Bylaws changes that were produced primarily from suggestions by Bighorse, Poe, McCoy, and Chadwick. Questions were answered and explanations were given. The Executive Committee will call a Special Executive Committee Meeting at the November Monthly Clubs Meeting to quickly go over the suggested changes and get the club's approval as warranted.

Chadwick also recommended Honorary Life membership to a special member of the Clubs. The Executive Committee unanimously concurred. Secretary Chadwick will initiate the process according to the Bylaws to nominate the unnamed individual to Honorary Life memberships status.

The clubs decided on the title Christmas Magic for the Clubs annual Christmas party. Members and guests will be requested to bring finger foods, do a gift exchange, invite Santa to appear, and have a special magic performance. With no further business, the meeting concluded at about 6:40 pm to start the club's November Thanksgiving Magic Monthly Clubs Meeting at 7:00 pm.



THE ART OF ASTONISHMENT

I remember distinctively when my dad asked me if I would be interested in seeing some magic tricks. It was only a few days before my eighth birthday. Honestly at that young age, I really didn't understand what he was talking about. I didn't know what a "magic trick" was. But not wanting to disappoint my father, I simply said yes.

A week or so later, a mysterious brown box arrived in the mail from the Johnson Smith Company. Dad spent some time combing through the five or six pocket tricks he ordered. Then he summoned his siblings to the dining room table. It was then that Dad reached up to the door trim and plucked a cigarette out of thin air! I was flabbergasted. How could that be? Was there some type of trap door made into the doorframe that concealed a cigarette? Later when he wasn't looking, I carefully examined the door area.

Dad wasn't a magician and there was nothing artistic about his performances. Certainly his ad hoc presentations left a lot to be desired. He simply performed puzzles. That didn't matter to me, however. My dad had done something impossible.

He then proceeded to torture me even more with a trick called the Ball and Vase. How could someone take a ball from a little plastic vase, place it into his pocket, close the vase with the lid, reopen it, and the ball would be back in the vase? It was unbelievable.

Needless to say, I was bitten by the magic bug. That led me into the quest to learn all I could about magic. I also quickly developed a never ending craving to acquire my own magic tricks. Unfortunately through the years that followed, I discovered that my quest had also become an addiction. Indeed I have spent thousands of dollars during my life on new magic tricks. Maybe the person who dies with the most toys really does win?

As I look back on those early days, I now see a pattern that I had no idea existed back then. The best way I can describe it is a sort of unquenchable lifelong thirst for more. I also now know that thirst also has a deceptive underbelly called dissatisfaction. What do I mean by that?

Like most magicians, I am thrilled to acquire new magic tricks. Unfortunately like most magicians, I fall pitfall to the fact that initial thrill and astonishment for new acquisitions quickly dwindles. Most of us in magic tend to go through magic tricks like water through a sieve. Often when we learn the secrets of our new acquisitions, we are quick to abandon effects like they have no longtime value. We pack props into storage bins, put them on shelves, fill our magic rooms, and then move on to find something "newer and better."

All of us as magicians should remember the impact and astonishment tricks have upon us the first time we see them performed. This is because magic tricks have similar impact upon laymen the first time they see them performed. Even simple effects can make great impressions on the uninitiated. We should never underestimate this.

Any magician who can develop this realization is on the way to understanding that magic tricks never lose their mystique. "Old magic tricks" can become new again. They are like raw ore ready to be processed. The magician's job is to take our magic tricks, routine them into an entertaining format, and bring their mysteries to life. That is the art of creating astonishment, and that of course that is what the performance of magic is all about.




In the Christmas tradition I created a novel square flexagon which gives the option of showing either Santa reading his naughty / nice book and giving a stocking of candy, or a disappointed Santa giving a stocking full of coal. Showing one Santa a few times in a row will make the other Santa surprising. Kid's will have fun with it, flexagons are interesting to mess with.

Both full images of the flexagon are perfectly centered on their 2 pages. If you double-side print, the images should perfectly line up and be oriented correctly. If for some reason they're not, I've added a small faint yellow star at the 2 corners to be glued back-to-back for the flexagon's proper alignment. I do highly recommend taking the time in adjusting them so just one sheet is used, double-thick flexagons tend to not perform well.

I'm not going to explain folding a square flexagon for 2 reasons, first it's difficult to explain in writing and second, there are numerous tutorials online. 'Square Flexagon' or 'Flat Flexagon' in a search window will provide numerous video tutorials. Making one and messing with it will make the following explanation more clear.

I created all the ai artwork and settled on watercolor to save ink when printing plus many inkjet printers tend to oversaturate and muddy the details of small images, watercolor's less intense on ink demand.

Begin with the flexagon opened where the 4 small separate images are on top, and the 2 ice skaters are at the front left corner and oriented from the spectator's perspective (ill. A). When you turn it over, the Christmas tree will be showing and oriented correctly (B). Now, if you fold the right side below the left (C) and reopen from the right edge, like opening a book, you'll show a happy Santa (D). Fold Santa's head beneath and reopen from your end, you'll show the candy stocking (E). If instead you fold the top of the tree beneath (F) and reopen from your end, you'll show an angry Santa (G), fold Santa's right half underneath and reopen from the stocking full of coal (H). To store, begin as in image (A), fold the turkey dinner and door underneath, next the right side underneath. It will be a nice little book with the skaters and frozen pond for the cover and back. To perform, simply reopen the opposite way and you'll be at the starting position (A).



More on the flexagon: After showing either stocking, the panel with the ice skaters won't be in the starting position (A) any longer. They can be easily maneuvered into position by folding them under and opening at the folded edge to move them to different quadrants. For example, after showing the stocking full of coal and doing another fold and open which returns to the 4 small pictures, the skaters will be at the upper right quadrant (I). By folding the skaters beneath (J) then reopening from the right edge, they will now be in the starting location (K), therefore everything else is correct and ready to go. For storage fold the turkey and wreath door beneath then the right side beneath and you'll end with a lovely little Christmas mystery package (L).



STALAGTITES: The following is my reworking of a Stewart James creation ('CUEMULAT4E' - Max Maven LISP series—Thunday, 1982 & The James File, pg. 1321) that will compliment this flexagon. It originally involved 12 playing cards from ace—queen of a suit. The glimpse happens when the packet is discarded onto the deck.

Preparation: Make 12 cards with a Christmas gift item on each face, also secretly number from 1-12. If the 12 items begin with the first 12 letters in the alphabet and in order (airplane, ball, cat, dog, etc.), if for example the glimpsed card is a <u>Game</u> console, 'G' is the 7th letter in the alphabet so the glimpsed value is '7'. Arrange in numeral order with gift 1 on the face, 12 on the back (top). Find a table with 3 people minimum.

- 1. Hand the face down, stacked in order packet to person #1. Ask them to deal it back and forth into 2 piles, pick up either stack and peek beneath it at the item on the face, remember it (random Christmas gift) and then place the packet onto the unchosen pile still on table, thus burying their item and recombining the packet. Ask person #2 to take the packet and repeat the identical random gift selection process person #1 did (dealing, picking up one stack, peeking at bottom card and dropping all onto the tabled unchosen pile). Lastly, the packet is given to the 3rd person for a final time doing the identical selection process.
- 2. Once person #3 has their item selected, pick up the recombined packet and put away, glimpsing the face card. That card's numeral value clues you to all 3 selections! Note: Values 1, 2, 3, & 4 are never glimpsed.

In this case I don't feel there's any need in looking / turning away during the selections process.

The First Selection will always be items 11 or 12, and is <u>opposite</u> in even / odd value as the glanced value. In other words if the glanced card is an even value, the selection is odd (11), or the glanced card is odd the selection is even (12).

The Second Selection is determined by 1 of 4 calculations: If the glanced value is 6 or 8 (low evens) subtract 5. If 10 or 12 (high evens) subtract 9. If the noted value is 5 or 7 (low odds) subtract 3. If 9 or 11 (high odds) subtract 7. As earlier mentioned, the values 1, 2, 3, & 4 are never glimpsed.

The 3rd Selection is determined by one of 2 simple calculations. If 9, 10, 11, 12 subtract 4, if 5, 6, 7, 8 add 4.

Now that you instantly know what items they've chosen, use the flexagon to show the preferred Santa and stocking, naming each gift selection as you do so. That should really surprise the Christmas bejeebers out of them! Merry Christmas, Happy Holidays, and all that wonderful stuff!


